This privacy statement provides information about the processing and protection of your personal data.

Introduction

In accordance with the [EU Regulation 2016/679](#) on Personal Data Protection ([Protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC](#)) and national laws, the Organizers (*the ERUA Alliance, and the University of the Aegean, as partner and administrator of the digital events*) treat the issues of personal data protection and security, seriously and carefully.

The ERUA Alliance and the Partner University have implemented internal policies and controls (Ethics and privacy protection manual) to ensure that your data is safe, not misused or disclosed, and accessible only to our staff to properly perform their duties. By participating in the events of the **#e-Science Cafes**, as participants, mentors, panelists, speakers, students and citizens, acknowledge that they have read and accepted this Data Protection and Privacy Statement and the terms and conditions outlined here.

This privacy statement explains the reason for the processing of your personal data in the context of the events of the **#e-Science Cafes**. It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. All personal data contained in the entries of the registration system in [ZOOM](#)¹ shall be processed, as mentioned before,

in accordance with Regulation (EU) 2016/679. The University of the Aegean as partner and administrator of the events is managing, in cooperation with ERUA partners, all the data gathered in the course of the **#e-Science Cafes**.

Why we are processing personal data

The Organizers (*the ERUA Alliance and the University of the Aegean, as partner and administrator of the events*), collect, process, store personal data in the ERUA Database, solely in relation to the **#e-Science Cafes**. All personal data are mandatory for the purposes outlined below. The purposes:

- To provide you with information about **#e-Science Cafes** events (before, during and after). Your data is collected to process your registration for participation in these events, to share among participants, to include them in the events documentation and follow-up for events evaluation purposes. Your personal data will not be used for any automated decision-making including profiling. Photographs and audio-visual recordings will be captured, before and during the events and will be taken and published in the context of the **#e-Science Cafes** events on the internet. Participants that do not wish to be part of the recording/publishing (or/and web-streaming) activities have the possibility to object to processing by sending an e-mail to the organizers prior to the events.
- To send communication emails with content related to the ERUA Alliance, **#e-Science Cafes** events, for interaction with other online tools.
- To invite you to attend the events as participant, mentor, panelist, speaker, student and citizen, and provide all type of events and follow-up communications, related to these events.
- To invite you to join and participate in selected related communities, and groups to cooperate with teams for common initiatives and projects.
- To verify an identity, to respond to any question submitted by participants, and to share your contact details in the **#e-Science Cafes** related communities, and groups.
- To publish details on the ERUA website, e- newsletter, social media channels in order to promote the events of the **#e-Science Cafes**.

Your consent is required for:

- The sharing of the events attendee list containing your name and affiliation among participants

- The processing of your personal data for inviting you to future events the organizers may organize
- To be contacted for evaluation activities in the context of the specified events
- The publication of photos and audio-visual recordings (or/and web-streaming).

If you register, you are giving us your explicit consent to process your personal data for those specific purposes. You can give your consent by ticking the box (es) on the online registration form. Your consent for these services can be withdrawn at any time:

The following of your personal data are collected:

- Contact details (first name, last name, gender, name and type of organisation, country, email address, job title)
- IP data, location data, collected automatically while registering for virtual meetings
- Virtual meetings are conducted through Zoom, during the processing of the operation the following additional information is collected: photographs/pictures, presentations, live web-streaming and/or audio and video recording of speakers and participants.

More specific data are collected for:

- **ERUA Webpage and Newsletter:** first name, last name, gender, name and type of organisation, country, email address, job title, photo, videos
- **Other type of communication such as email alerts and updates:** first name, last name, gender, email, organization name and role/job.
- **Invitations to events:** first name, last name, gender, email, organization name and role/job.
- **Participation in selected related communities and groups:** first name, last name, gender, email, organization name, country, role/job, photo, videos
- **Participation in the online events:** first name, last name, gender, email, organization name, country, role/job photo, video, power point presentation, recording image or voice.

Who has access to your data?

- The recipients of your personal data will be authorized ERUA and Partner's University staff in charge of conducting and administering the **#e-Science Cafes** events.

- Your personal data may also be shared with bodies and structures in charge of monitoring tasks (e.g. internal audits, accounting, legal departments).
- Some of your personal data might be made available to the general public for promotion purposes: your first name, last name, organization name and role/job, photo, video.
- Your personal data will not be transferred to third parties or other international organizations.

How long is data retained?

Your personal data will be kept for a maximum period of two years in the ERUA Database until the results of these events are published and put to meaningful use. After this period the Data will be deleted.

Your rights

- You have the right, upon written request, to access your personal data, verify which is stored, and have been modified, corrected or deleted.
- You have the right, upon written request, to access to your personal data and correct any information that is inaccurate or incomplete.
- You have the right to withdraw your consent at any time, update your contact information, or request a free copy of these Rules at any time by contacting us.
- You have the right to address any questions regarding the processing of your personal data.

You also have the right to lodge a complaint with the supervisory authority if you believe that the processing of personal data relating to you is in breach of data protection regulations (Art. 77 GDPR. The competent supervisory authority for the University of the Aegean is the DPA ([Hellenic Data Protection Authority](#)))
